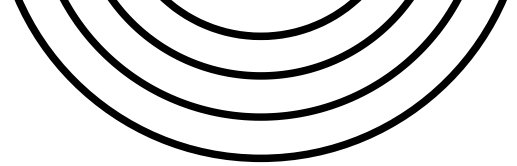

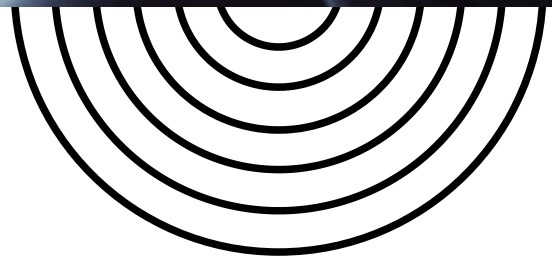
As an RPA, practitioners engage in rigorous Continuing Professional Development (CPD) and adhere to a strong Code of Ethics for the protection of the public interest.

## Requirements to become an RPA Practitioner

1. **RPA Membership:** Must be an RPA member in good standing.
2. **Educational and Training Requirements:** Must complete the education and training necessary for obtaining a practitioner certificate.
3. **Practical Experience:** Must have at least 5 years of practical experience in public accounting.
4. **Ethical Standards:** Must adhere to the RPA Code of Ethics.
5. **Continuing Professional Development:** Must maintain a minimum number of Continuing Professional Development (CPD) credits annually.
6. **Public Protection Compliance:** Must participate in the complaint process designed for public protection.
7. **Insurance:** Must maintain Errors and Omissions insurance.
8. **Practice Review:** Must participate in periodic practice reviews to ensure ongoing compliance and professional standards.

# RIGHTS & RESPONSIBILITIES OF RPA PRACTITIONERS



1. Become a Certified Accounting Practitioner
2. Eligible to sign Compilation Engagement Report
3. Eligible to become Commissioner for Taking Affidavit
4. Qualify to access Ontario Business Registry as an Intermediary Partner
5. Prepare and file personal and corporate tax returns and related tax filings
6. Eligible for Error & Omission Liability Insurance
7. Maintain Continuing Professional Development (CPD)
8. Follow RPA Code of Ethics & Professional Code of Conduct
9. Cooperate in the public complaint process if any
10. Cooperate in a Period Practice Review process
